General Conditions

RESERVATIONS

1. Reservations shall be made through A BlackTie Affair Travel Group, LLC., (BlackTie) acting as a collecting agent for the Tour Operator. Please book as early as possible for each group has limited space. Failure to comply with the deposit and final payment requirements will result in automatic cancellation of reservation and penalty charges will apply. Tour fares are based on double occupancy. BlackTie is not responsible for finding you a roommate. A single supplement fee of **\$575** may be applicable if you cannot identify a roommate to lodge with you.

If this tour includes the travel of minors, it is agreed that an appropriate ratio of adult chaperones to minors be maintained throughout the tour.

2. A **\$300** deposit is required at the time of booking. BlackTie will deposit all funds in a business client's trust account until payment is requested by its agents. The balance of your tour payment is due **30** days prior to departure. Acceptable forms of payment on this tour include cash, money order, cashier's check, or personal check. For your convenience, deposits shall be paid according to the following schedule:

CANCELLATION POLICY

When a reservation is cancelled, the following cancellation charges will apply:

59 days to 30 days prior to departure:30% of total price
29 days to 15 days prior to departure.....65% of total price
14 days or less before departure100% of total price

TOUR FARE INCLUDES

1. Air transportation - round-trip group rate ticket on economy class, with departure from Los Angeles
2. Hotels - Costs are based on two people sharing a room with 2 beds. For persons requiring a single room, the single supplement cost is shown. Requirement for single room should be indicated when making reservations and payment of single supplement shall be made
3. Meals - three meals a day at hotel or local restaurant except on a designated leisure day
4. Sightseeing - Tours as indicated in itinerary. If circumstances dictate (like weather, time, safety, political factors or others), an alternative program will be arranged

As required by the Chinese government, the tour operator has bought travel insurance in China for all passengers from the Insurance Co of China. Besides, the tour operator provides all passengers \$200,000 travel protection insurance on international flights. BlackTie recommends all tour guests purchase additional travel insurance protection.

RESPONSIBILITY

BlackTie acts as collecting agent and liaison to the tour operator. The suppliers providing transportation, conveyance or accommodations are independent contractors and are not agents or employees of A BlackTie Affair Travel Group. All tickets, coupons and receipts issued by BlackTie and all arrangements for transport or conveyance or for hotel accommodation are made by BlackTie as agent of the suppliers. By utilizing the services of suppliers, you agree neither BlackTie nor any subsidiary or affiliate of BlackTie shall be liable for any injury, errors, damage, loss, accident or delay incurred upon you or those traveling with you in connection with any accommodation, transportation or other services resulting directly from any acts or default of suppliers or from any occurrence or condition beyond control of BlackTie including defects in vehicles or breakdown in equipment. Nor shall BlackTie liable for any injury, damage, loss, accident, or delay resulting directly or indirectly from delays, cancellation or changes in flights, itineraries, schedules, steamers or other services, strikes, theft, sickness, weather, quarantine or other causes. All tour itineraries and fares may be affected by alterations or delays in air or surface transportation services. BlackTie reserves the right to withdraw any tour in this program and to make such alterations in the itineraries as may be found desirable for the convenience of the parties or the proper operation of the tour. 2. All participants must carry valid passport, visa or other travel documents; even though BlackTie will not be responsible in case an entry cannot be allowed for personal reasons by the immigration or custom service; all tour fees are neither refundable nor transferable.
3. BlackTie reserves the right to cancel the tour prior to departure for any reason. Liability for such cancellation is limited to full refund of money received by BlackTie and this will constitute full settlement with the tour member.
4. If sufficient members have not booked by **45 days prior to departure date**, the China Tour may be cancelled. In that event, tour deposit monies which were collected will be refunded.
